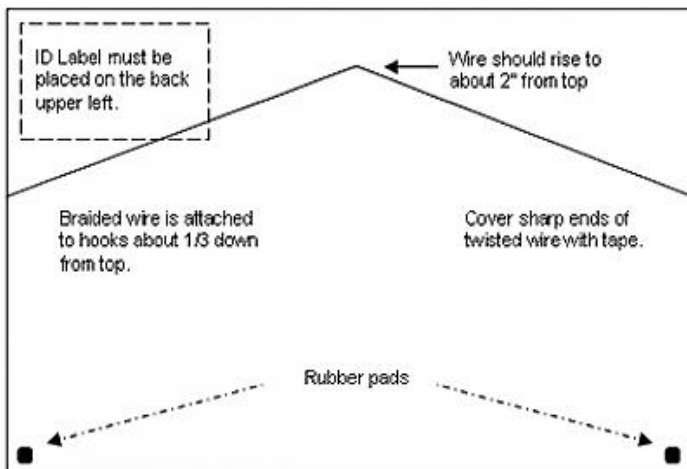


Annual Member Exhibition Registration Form

**“Colors of Joy” to be held April 7, 2018 to May 13, 2018 at the
White Bear Unitarian Universalist Church, 328 Maple St, Mahtomedi, MN 55115**

Eligibility

- Display one painting for each paid member of NorthStar Watermedia Society
- Artwork previously exhibited with NSWS is not eligible
- Artwork must be painted after January 2016 and be completely original to the artist
- Each artist may submit one painting done in watercolor, acrylic, casein, gouache, water-soluble ink, and/or egg tempera with no more than 25% collage.
- Acceptable surfaces are paper, yupo, canvas, canvas board, or board.
- Each must be framed or wrapped with finished edges containing no visible staples



- All paintings must be wired for hanging on the vertical sides of the frame.
- All framed paintings with a total frame length (all 4 sides together) of over 100 inches must be behind acrylic, not glass.
- White, off-white or neutral colored mats are preferred.
- Maximum size, with frame, is 40" in any direction.

- Paintings must be priced for sale or identified as Not for Sale (NFS).
- No work may be withdrawn before the close of the exhibition
- A fee of \$30.00 must be received with this registration payable to NSWS
- The artist is responsible for insurance on the artwork
- All members are encouraged to have available, a jpeg photo of their painting (without the glare of glass) to be used for the PP award presentation should they win an award.

Deadline for registration at the meeting or by mail is March 15, 2018.

Drop-off Saturday, April 7, 10:00AM to 1:00 PM Hanging after 1:00 PM

Reception May 10 6:00 – 8:30 PM Awards presentation at 7:00 PM

Pick up Sunday, May 13, 1:00 PM to 3:00 PM. Late pickups will incur a \$25 fee.
