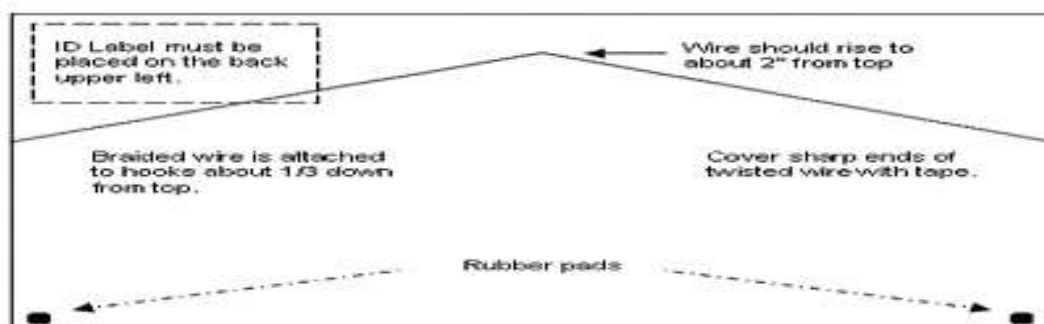
- Display one painting for each paid member of NorthStar Watermedia Society
- Artwork previously exhibited at an NSWS Exhibition is not eligible
- Artwork must be painted after January 2016 and be completely original to the artist
- Each artist may submit one painting done in watercolor, acrylic, casein, gouache, water-soluble ink, and/or egg tempera with no more than 25% collage.
- Acceptable surfaces are paper, yupo, canvas, canvas board, or board.
- Paintings must be framed or wrapped with finished edges containing no visible staples
- Maximum size, including frame, is 40” in either direction.
- Paintings must be priced for sale or identified as Not for Sale (NFS).
- Paintings must be wired for hanging on the vertical sides of the frame.
- Paintings with a total frame length (all 4 sides together) of over 100 inches must be behind acrylic, not glass.
- White, off-white or neutral colored mats are preferred.
- No work may be withdrawn before the close of the exhibition
- A fee of \$30.00 must be received with this registration payable to NSWS
- The artist is responsible for insurance on the artwork
- All sales are between the artist and the buyer. Artist is required to send a 10% commission to the church.

Deadline for registration at the meeting or by mail is February 21, 2019.

Drop-off Saturday, March 9, 10 AM to 1 PM Hanging after 1 PM

Reception Thursday, March 21, 2019, 6 PM to 8:30 PM, Awards presentation at 7 PM

Pick up Sunday, April 14, 2019, 1 PM to 3 PM. Late pickups will incur a \$25 fee. (No exceptions!)
