
James Nutt is an architect, artist, instructor and constant sketcher. He practices architecture at BWBR in St Paul and teaches watercolor and urban sketching. Sharing a studio in the Northrup King building, he participates in monthly open studios, Art-A-Whirl, commissions, and art demonstrations.

James draws and paints constantly and carries a small kit everywhere to capture the story and energy of places and ordinary things. He focuses

on energy and depth through deliberate proportion and harmony rather than accuracy. His work covers a wide range from abstract to illustration but always with an emphasis on relationships and story-telling.

In his demo, James will do a brief introduction to his process and then walk us through a painting filmed onsite while he talks through his strategy, tools, and tips. There will be a question and answer period at the end. He will share a blog post that explains his water color kit, brushes and everyday tools at www.nuttdraws.com





"I love what can be done with an energetic line, an eye on proportions, and just 3 primaries to mix from. These constraints allow me to concentrate on narrative relationships and help squeeze art into the rare still places in the day," he says.

Keiko was great! . . . wonderful demo . . . I could really see what she was doing." Keiko painted a Japanese temple scene entitled, *Journey Home*. She has graciously agreed to allow NSWS members to access the video of her painting demo. Keiko Tanabe began her demo by explaining that she would combine an image of a temple in the background with boats in the foreground. The temple is the Golden Pavilion in Kyoto, Japan where Keiko was born. She included 3 boats with figures in the foreground. Since these were familiar images for her, she didn't need a photo. After drawing the scene on Arches rough paper, she wet the paper and painted a warm sky with raw siena and quinacridone gold, then dark trees which blurred into the sky. She painted right through the boats with yellows and light purples, spattering with paint and water. Nothing had hard edges.

Leaving this first wash to dry, she explained her approach from vision to drawing to a first stage where she considers color harmony, lights, and darks, and then the final finishing stage, still maintaining a soft look. The three boats with figures tell the story. She added a tree branch coming into the sky, using confident brush strokes. Her brushwork is energetic, alive, and meaningful.

Why did you decide to become a member of NorthStar and why did you decide to serve on the board?

I had just begun taking classes at the White Bear Center of the Arts when I learned about NorthStar. I went to my first meeting and joined then. Being new to the area and also a new member of Minnesota Watercolor Society, I thought that this would be the perfect way to bridge my move, maintain my relationships, and develop new ones.

Tell us a little about yourself.

I am a native Minnesotan and graduate of the University of Minnesota. I have a diverse background. I taught

middle school science for 5 years, was Director of Sales at the Carlton Celebrity Theater, a community volunteer for the Friends of the Institute, MN Zoo, MN Orchestra, and the Assistance League of Mpls/St. Paul. I recently retired from a 25 year career in corporate event planning for the automotive industry. Besides art I enjoy food, wine and travel. I have had the good fortune to travel extensively and am so fortunate to have visited and admired many of the greatest art museums and the natural wonders of the world.

Tell us about your artistic education, experience, and interests.

I came to watercolor relatively late in my life. I took informal classes from Jan Forbes in her home, mainly for stress relief. I loved the color and the process, but I didn't have the time to devote to truly learning until my retirement, when I

began taking classes from Marian Alstad, Frank Zeller, Catherine Hearding, and David Smith. I feel that I am going back to school. It is a process and it takes practice and more practice. The only good thing about COVID-19 is that I have nothing but time to paint. I am so grateful for my passion of watercolor.

ARTREACH FOR JUSTICE

This column will highlight artists, places, and events in keeping with our commitment to work toward a more inclusive, just, and equitable art community.

You know how once you've heard about something, suddenly you see it everywhere? Local artist Leslie Barlow first came to my attention for her work with #CreativesAfterCurfew, a group that came together to create street art in community response to the killing of George Floyd in May.

Shortly afterwards, her name popped up on my InstaGram feed as the leader of Studio #400, an emerging artist collective located in the Northrup King Building where I happen to share a studio with several other NorthStar members.

When I saw Barlow's art mentioned again in <u>"Strangely Fine," a Star Tribune article</u> about the State Fair Fine Art Show, I knew I had to know more! I searched for images of her paintings, and I learned that her 2018 State Fair entry, <u>"Stephen, Jeffrey and Twins" (2017)</u> was acquired by the Minnesota Museum of American Art!

Most recently, Barlow's name appeared in an email from the White Bear Center for the Arts as the curator of their current exhibit, "Disquietude". The show features two of Barlow's own drawings, as well as works by her current group of Studio #400 artists. WBCA has posted an excellent YouTube video tour of the exhibit that includes an introduction by Ms. Barlow and interviews with each artist. Although Barlow herself works mostly in oil, several of the artists in the exhibition work in watermedia, notably Philipo Dyauli, Maiya Hartman, and Sarah Nicole. I think you'll enjoy checking them out!

How could I not have known about Leslie Barlow's work before!

Visit her website -- <u>Leslie Barlow Artist</u> -- to read about her many accomplishments and view examples of her paintings, which "share stories through the figure and portraiture exploring issues of multiculturalism, identity, representation, trauma, and race."

ART 4 SHELTER 2020

Despite the Covid-19 pandemic, Art 4 Shelter had another successful year!

The challenges this year included:

- Cancellation of March watercolor society meetings to collect donations of art
- Art 4 Shelter event cancelled and switched to an on line event.
- Operating expenses at Simpson increased due to changes to protect both the homeless clients and Simpson staff.

Results of event:

- 900 pieces of art were donated by 150 artists.
- 87% of Art sold in first week.
- 128 supporters paid \$100 for a "first look" and an opportunity to purchase art early.
- Artwork sold raised \$77,000, and provided 2,200 nights of safe shelter for the homeless.

15 sponsors donated \$30,000.

Thank you to artists who donated art for this event. Members of MNWS and NSWS have contributed generously to this event during the past 10 years. I hope some of you have been contacted by patrons who purchased your art.

TIPS AND TRICKS

How to make whites appear white when photographing your artwork


A few years ago I was photographing a painting that had a lot of white and a lot of green. I was frustrated because the photos showed the white as light green. I tried using Photoshop to lower the saturation of the green to get the whites back, but that changed the greens to brown. Ugh!

In a Google search I learned that the greens invading my whites were called "digital noise" or unwanted color pixels that the camera picks up from surrounding areas.

Recently I was photographing a couple of images with a white background. Even with precautions, I was again having issues with white areas. I tried to remove color cast (Enhance>Adjust Color>Remove Color Cast) which helped but did not get rid of the "noise."

Finally, I used Help on Photoshop, which led me to Adjust Lighting (Enhance>Adjust Lighting>Levels). In the Levels menu there is a little eye dropper image. Select the one with white (circled in red in this screenshot photo). Click on it, touch it to one of the areas that should be white, and click again. You may need to repeat it, especially if you adjust the overall color again.

I use a tripod and a remote shutter release, so that I do not jostle the camera by touching it, and I shoot the image in Raw setting which allows me to change



settings like full sun to shade. I use a low ISO (100) and a low numbered aperture (f4-f8). I like to photograph artwork outdoors on a cloudy day that is not too dark or open shade.
