Darius Steward is known for his figurative work and for his public outreach through murals. He is currently living in Cleveland Ohio. Darius graduated from the University of Delaware obtaining a Master of Fine Arts degree in May 2010. His undergraduate work was completed at the Cleveland Institute of Art with a concentration in drawing and painting. Darius has shown artwork in museums and galleries across America. Some of his most notable exhibitions include solo shows at the Swope Museum in Indiana and the Canton Art Museum in Ohio. Darius has completed murals with Inter-Urban Art Project and Tri-C, Midtown, Cleveland.

"I paint with watercolor on YUPO or Twinrocker paper to achieve stark whiteness against my saturated subjects. I often use my subject metaphorically to address what is going on culturally. Each and every person I paint is a stand-in for myself

or for the community. I use watercolor portraiture and my large murals to bring a voice to social injustices which are going on in the world."
